#### I. TERMS AND CONDITIONS OF CONTRACT

#### 1. Artwork and Design

- (a) The Artwork to be prepared by the successful agency under guidance of this office.
- (b) The Successful Agency should submit at least 3 designs and layouts (both for cover/inside). Provision of pictures/animation, wherever used will be integral to the design. Of the designs submitted by the agencies, a suitable design will be selected by Competent Authority of NCW and ownership of selected design rests with the National Commission for Women.
- (c) National Commission for Women shall be free to use the design in electronic, print or any other medium. All Rights of reproduction, editing, publicity and future use shall rests with National Commission for Women unless otherwise stated explicitly and agreed at the time of acceptance of design.

#### 2. Preparation and submission of tender document:

- (a) The bidder has to submit the tender document duly signed on all pages by an authorized person and his / her full name and status be indicated below the signature along with official stamp of the firm. Submission of wrong / forged information / document will be liable to legal action, forfeiture of EMD and rejection of tender submitted by the firm.
- (b) The bidder shall enclose the following along with Bid. Any tender documents without these shall be invalid and rejected.
  - a. Work Order of Printing of Similar Work, i.e. multi-colour Annual Reports/Books/etc. from at least two Central/State Govt./autonomous govt. organizations/PSUs
  - b. Copy of registration certificates, Viz. VAT Registration, TIN number, PAN Card and Service Tax Registration
  - c. Sample papers, with the description of the paper viz brand, make, GSM etc..
  - d. Documentary evidence of own printing press Press Declaration / License / etc.
  - e. Undertaking on Letter Head that the bidder has not been blacklisted by any govt. Department and must not have any criminal case registered against the firm or its owners/partners anywhere in India.

- (c) Tender received without required EMD or lesser amount will be summarily rejected. However, firms registered with NSIC and have a valid registration certificate are exempted from payment of EMD.
- (d) The tenders of the agency not in possession of valid statutory license / registrations are liable for rejections.
- (e) The tender submitted by the firm / agency shall remain valid for 90 days from the date of opening for the purpose of acceptance and award of work. Validity beyond 90 days from the date of opening shall be by mutual consent.
- (f) No bidder will be allowed to withdraw / alter / modify after submission of tenders within the bid validity period otherwise the EMD submitted by the bidder would stand forfeited.
- (g) EMD will be liable to be forfeited if the bidder selected for the work fail to accept, execute and complete the work on the date stipulated in the work order.

#### 3. Work Order and Security Deposit:

- (a) A work order shall be issued to successful bidder. The bidder shall deposit an amount equal to 10% of the value of contract (after adjusting the EMD) as Security Deposit in the form of Demand Draft in favour of Pay & Accounts Officer, National Commission for Women from any of the Nationalized/Scheduled Banks payable at New Delhi, which would be released on expiry/termination of the contract after adjustment of dues, if any.
- (b) The Security money so deposited will be liable to be forfeited or appropriated in the event of unsatisfactory performance of the contract, if any, sustained by the Commission on account of failure or negligence on the part of successful bidder.

#### 4. Right of National Commission for Women:

- (a) The National Commission for Women reserves right to withdraw / relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
- (b) The National Commission for Women reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever and its decision shall be final and binding on the bidder.
- (c) The National Commission for Women reserves the right to terminate the contact at any time without assigning any reasons by giving fifteen days notice to the contracting agency/firm/company.
- (d) National Commission for Women reserves the right to suitably increase / reduce

the scope of work put to this tender. In case of any ambiguity in the interpretation of any of the clauses in the tender document or the contract document, interpretation of the clauses by the National Commission for Women shall be final and bindings on all parties.

#### 5. Breach of Terms and Conditions:

- (a) The work order can be terminated by the National Commission for Women if it is felt that the work carried by the contractor is not satisfactory. The contractor shall not be entitled for any compensation on account of such force closure / termination of contract.
- (b) In case of breach of any terms and conditions as mentioned above, National Commission for Women shall have the right to cancel the work order without assigning any reason thereof and nothing will be payable by National Commission for Women. In that event the security deposit shall also stands forfeited.

#### 6. Settlement OF Disputes & Arbitration

In the event of any dispute or difference whatsoever arising under this contract or in connection therewith including any dispute relating to existing meaning and interpretation of this contract, the same shall be settled amicably in the first instance. All unresolved disputes/differences shall be referred to the sole arbitration of mutually agreed person appointed by the Chairperson, National Commission for Women.

#### 7. **Jurisdiction of Court**:

This contract is governed by the laws of the Republic of India and shall be subject to the exclusive jurisdiction of the Courts in Delhi.
