Capacity Building for State Women Commissions in association with LalBahadurShastri National Academy of Administration (LBSNAA)

The National Commission for Women conducted training programmes for the Chairpersons and members of the State Women Commissions to build capability in gender and related areas of law, working with stakeholders like the police, among others in association with the National Gender Centre, LBSNAA. The objective of the programme was to engage in deliberations and dialogue on multiple themes dealing with women issues.

The training for the 2nd Batch was conducted from 29th to 31stJuly, 2019 while the training for the first batch was conducted from 19th to 21st June, 2019. The training was conducted at LBSNAA campus in Mussoorie. The programme was attended by 41 participants from State Women Commissions across 13 states. Participants brainstormed and discussed multiple aspects of issues related to women – be it societal in nature like patriarchy or stakeholders like media, the laws related to women and the challenges that obstruct the way ahead.

Acid attacked survivor turned social activist Ms. LaxmiAgarwal addressed the participants and highlighted the role of State Women Commissions in counseling the survivors, their family members, supporting and guiding them about the process and the steps like FIR registration, etc. Recalling personal examples, she expressed that lack of awareness among the survivors was a common challenge that impacts them adversely. She also spoke at length about how the law had evolved over a period of time to support a victim in terms of free treatment at private hospitals, compensation formula based on the degree of burns, etc.

Discussion on NariAdalat



The National Commission for Women organized a preliminary consultation meeting on proposed NariAdalat model with senior officers from the Ministry of Women & Child Development, Principal Secretaries/ Representatives from 9 State Governments and respective State Women Commissions for Women on 31stJuly 2019. The meeting was presided over by Smt. Rekha Sharma, Chairperson, NCW. NariAdalats have been very successful for resolving marital/family disputes in Gujarat, the consultation was organized to deliberate on implicating this model into a pan-India model with learnings from Gujarat.

Following recommendations were agreed upon during the discussion.

- NariAdalats should be set up not only for delivery of justice but also for promotion and propagation of legal literacy particularly for women in rural areas
- As per the proposed administrative structure, the presence of district committee is necessary given the need of convergence of multiple schemes
- Constitution of NariAdalats must be socially inclusive and represent areas they function in
- It was suggested that the project be rolled out in a phased manner starting with 25 districts in the first year excluding North-East and the Union Territories





Gender Sensitization Programme for Police officials

The National Commission for Women has been conducting Gender Sensitization workshops and programmes across the country for Police Personnel/ Judicial Officers, with a view to sensitize them on gender issues. The programme aims at bringing behavioral change in police personnel to enable them to act without prejudice and with compassion while dealing with victims of gender based crimes and women in general.

The Commission organized a one day Gender Sensitization Workshops at Indore, Madhya Pradesh in collaboration with State Police Academy on 7th July 2019. The gender sensitization programme for Women Police officers was held atMysuru, Karnataka from 17th July to 19th July 2019, in collaboration with Karnataka State Police Academy. It is expected that after undergoing this trainingthese officers will be able to empathize with the victims/ complainants of gender-based crimes and women in general and assist them in a better manner.

The National Commission for Women had taken cognizance of media report captioned "Rape victim' attempts suicide in Rajasthan police Station" appeared in The Tribune dated 28thJuly 2019 wherein it was reported that a rape victim had allegedly attempted suicide at a police station in Jaipur demanding the arrest of the accused, her husband's cousin. The Commission had constituted a two member Fact Finding Team to look into the matter. The team visited the police station wherein the victim had attempted suicide and conducted an inquiry into the incident. In response to this, the team received a detailed Action Taken Report in the matter during the visit from DGP Rajasthan and Commissioner Jaipur.
