The National Commission for Women organized a one-day 'Capacity Building Training Programme' for Women Traders of Manipur on July 5, 2022 in collaboration with the State Commission for Women for holistic development of women traders and to create more entrepreneurial opportunities for them.

Shri N Biren Singh, Hon'ble Chief Minister, Manipur, Shri Heikham Dingo Singh, Hon'ble Minister, Social Welfare, Manipur and Chairperson, NCW, Ms Rekha Sharma graced the occasion.

Ima Keithel of Manipur is said to be the largest all-women market in Asia with large number of women manning the stalls in these markets. In pursuance to the Commission's programmes in North-eastern states, NCW conducted this one-day training programme for women traders of three Ima Keithels to improve their livelihood, social security and overall quality of life. The 1st session was on 'Knowledge of Relevant Banking Schemes and How to Use Online Banking'. The second session was on the topic 'Knowledge of Tax Laws/GST Laws and Tax Compliances and the final session was on 'E-Commerce Demonstration.

## NCW launches Series of Awareness Programmes on NRI Marriages in Punjab

The National Commission for Women launched a series of 'Awareness Programmes on NRI Marriages: Do's and Don'ts, A Way Forward' across different districts of Punjab on July 11, 2022 to disseminate information on the possible risks involved in NRI marriages, and to create awareness around preventive measures and legal remedies available for victims.

Ms Rekha Sharma, Chairperson, National Commission for Women, Shri Kuldeep Singh Dhaliwal, Hon'ble Minister of NRI Affairs, Government of Punjab, Prof Arvind, Hon'ble Vice Chancellor, Punjabi University and Ms. Meeta RajivLochan, Member Secretary, NCW graced the occasion.

The awareness programs are being held in collaboration with Department of Law, Panjab University and in association with SGPC, Punjab State Legal Service Authority, Punjabi University, Guru Nanak Dev University, Panchayats, NGOs and the local police. The sessions will deliberate upon the challenges faced by aggrieved women in getting relief through remedies available under legal system and to seek possible solutions to effectively reduce them.

The programme was divided into four technical sessions; 'Role of judiciary in providing relief to women aggrieved in NRI Marriages', 'Role of Police', 'Role of legal machinery' and 'Sociological aspects of NRI Marriages'.

The Consultation for Southern Region was held in collaboration with National University of Advanced Legal Studies, Kochi on 16.07.2022.
