## Progressive Steps Towards Rehabilitation and Justice

Under the leadership of Chairperson, Ms. Rekha Sharma, a distinguished Inspection Committee, accompanied by Members Ms. Delina Khongdupr and Ms. Mamta Kumari, as well as Special Rapporteur Ms. Shreya Sen and a respected advocate from D.S.L.S.A., embarked upon a profound visit to Tihar Jail, Delhi. The team focused on examining the living conditions of resilient women inmates in Jail No. 6. During the visit, the Hon'ble Chairperson personally interacted with all the women inmates, whether they were undertrial or convicts, including foreign prisoners. She compassionately inquired about their well-being and any issues they might be facing, especially concerning legal aid facilities, grievances, and availability of counseling services. In response to their needs, the Committee took dedicated steps to address any identified concerns, directing the Prison Authorities and Legal Aid Counselors to take prompt action in this regard.



The National Commission for Women in collaboration with Entrepreneurship Development Institute of India, Ahmedabad conducted an Entrepreneurship Development Programme in Budgam, Jammu and Kashmir to strengthen and build entrepreneurial capabilities among women entrepreneurs of the region.

As per the directions of the Hon'ble Chairperson, NCW, and a Complaint from People Against Rapes in India (PARI), Delhi on the unfortunate death of Ms. Bhawana, a disabled woman staying in a Shelter Home named "Bright The Soul Foundation (BTSF)", functioning at Loni, Ghaziabad, the Inquiry Team, chaired by Hon'ble Member Mamta Kumari assessed the ground situation and directed the Ghaziabad district administration to relocate of all the remaining residents to better governmental shelter facilities as per their needs. Also, directed the Ghaziabad Administration and Police to investigate the issues and provide an Action Taken Report in this regard.



Mahila Jan Sunwai was convened by National Commission for Women in Alwar, Rajasthan in collaboration with concerned DLSA, Police authorities. 34 complaints were taken up by Hon'ble Member Ms. Delina Khongdup to provide speedy redressal.

Hon'ble Chairperson Ms. Rekha Sharma visited the Central Jail in Srinagar where she met and interacted with 47 women inmates. She directed the jail authorities to provide proper legal aid to the inmates through the District Legal Service Authority (DLSA). The National Commission for Women celebrated 9th International Yoga Day. All the officials of NCW practised Yoga on the occasion.



Hon'ble Chairperson Ms. Rekha Sharma held a meeting in Kargil with various stakeholders including the Deputy Commissioner, Additional SP and other authorities. Key issues related to various Schemes for Women in the district was discussed with special emphasis on Begum Hazrat Scheme to ensure that women are not married off on attaining 18 years of age to claim the benefit under the scheme. Instead, the scheme should benefit independent women who are working and financially independent. The Hon'ble Chairperson sought data pertaining to this Scheme which is availed by women from the villages of the border region and also directed the authorities to take new and better initiatives for uplifting women from these regions.



The National Commission for Women organised a Two day Workshop on "Gender Sensitization and Forensic Training of Police Officials of Delhi" at Specialized Training Center, Police Station, Rajender Nagar, New Delhi. The workshop commenced under the Chairpersonship of Ms. Rekha Sharma. This two days workshop aimed to make police officers act in a gender sensitive manner in cases of violence against women and in the discharge of their duties in general.
