Important Decisions

- The Delhi High Court has enhanced the sentence awarded to a rape convict by the sessions court from three to seven years of imprisonment saying that sexual offences against women are increasing and such crimes have to be dealt with strictly and no leniency should be shown to the offenders. The court said, "rape is a heinous crime not only against the individual but also against the society at large. Therefore, considering the age of the prosecutrix at the time of commission of the offence.... it is not a fit case where a sentence less than the minimum of 7 years should be awarded."
- The Prime Minister launched the stand up India scheme, under which 125,000 bank branches will provide loans between 10 lakh to 1 crore to SC/ST and women entrepreneurs. Every branch has to provide at least one loan. The scheme will add 250,000 new entrepreneurs.
- The Indian Navy has begun granting permanent commission to women officers while also considering a policy to allow them on warships in the country's male-dominated armed forces.
- The Supreme Court's ruling in favour of Mumbai dance bars came as a relief not only to the Mumbai girls but also to many village girls in far-off States. After closure of dance bars in Mumbai, a number of women returned to their villages with a considerable amount of money and built houses. But to sustain themselves they were compelled to choose prostitution. The girls now hope to earn enough so that they will never have to go back to the flesh trade.

Women Political Empowerment Day

The Institute of Social Sciences (ISS) celebrated the Women Political Empowerment Day, sponsored by UNICEF, the Asia Foundation and Water Aid on 24th and 25th April, 2016, on the theme "Panchayats and Sustainable Development Goals" commemorating reservation for women in local governments through Constitutional Amendments in 1993. About 300 delegates from across the country participated in the celebration.

Three elected women representatives, Ms Hansa Devi from Dewal village of Uttarakhand, Ms. D. Myla, from Dharmapuri district in Tamil Nadu and Ms Dinja Jakesika from Rayagada district of Odisha were conferred Outstanding Women Panchayat Leader Awards.

In her inaugural address, NCW Chairperson Lalitha Kumaramangalam, the chief guest, spoke at length as to how women's will and determination count, irrespective of their caste or religion, while entering public life. She lamented that even today, for policy formation and development, women are hardly brought on board during the planning phase.

Speaking on the occasion, Ms Monica Lanzetta Mutis, Ambassador of Colombia, cited that in Colombia 52 percent

of the population are women and 30 percent of seats of every political party from the municipalities to the Senate are reserved for women.

Dr. George Mathew, Chairman ISS, in his concluding remarks over the 2-day programme, highlighted the significance of celebrating women's political empowerment following 33percent reservation of seats for women in Panchayats. Others who spoke on the occasion included Dr. Ash Narain Roy, Director ISS, Dr. Bidyut Mohanty, Head, Women Studies ISS, Ms. Swati Maliwal among others. Ms Rebecca. R.Tavares, Representative, UN Women, delivered the valedictory address.

Seminar on Hindu Jurisprudence

A 3-day-national seminar on 'Hindu Jurisprudence' was organized by India Foundation with the support of Indian Council for Philosophical Research (ICPR) at IIC in New Delhi.

Delivering the keynote address at the valedictory session, NCW Chairperson Lalitha Kumaramangalam maintained that condition of women in the country has witnessed "significant" positive changes in the recent past but a lot still needs to be done". She said that laws made until 1980 had constantly looked at women as objects and poor economic status of women was also responsible for restricting them to their households. She called for equal opportunities for women, rather than equality.

Thereafter, she completed her education till class 10, went to Gurgaon to learn computer, worked at the Panchayat Samiti for a year and gained a sound understanding of village administration. Later, she entered the political arena and became the only woman Block Pradhan of Manohar Thana Panchayat Samiti, at Jhalawar district, in Rajasthan.

Setting an example, she built a toilet in her community, and taught people the importance of cleanliness. Above all, the husband who left her years ago, stands by her today and she is helping him to complete his B.Ed.

Morrambai Tanwar's is a story of unflinching courage and impeccable honesty in the face of extreme adversity, a woman, who in the real sense empowered herself.

Training programme for Elected Women Representatives

The National Commission for Women in collaboration with the Tata Institute of Social Sciences, Mumbai, has developed capacity building modules for empowering elected women representatives at Panchayat and Zila Parishad levels that aims at developing their capacities in administrative skills. The training module focused on understanding the socio-legal and constitutional frameworks to safeguard and secure the rights of women; state-sponsored schemes and welfare programmes as well as knowledge of institutions, structures at the village, block and district level.

The three-day training programme attended by 40 elected women representatives was inaugurated by NCW Chairperson Lalitha Kumaramangalam at Jhalawar district in Rajasthan. Member Rekha Sharma, Member Secretary Preeti Madan, Ms Richa Ojha, Ms. Avni Bahri and officials of Jhalawar district were present.

Six signs of a stalker: Won't take no for an answer; has an obsessive personality; loner with few personal relationship; lacks guilt, embarrassment or discomfort; low self-esteem, sociopathic, doesn't learn from past behaviour.

You are being stalked if you are subjected to: frequent and intrusive texts, calls or emails, unwanted attention, gifts or flowers, following or hanging around your home, school or office, threats to harm you or your family, friends or pets, damage to property or threats about it.
